



# BRI FC SCHOLARSHIP

---

## A. General

The scholarship program policy explains the process followed by BRI FC to evaluate, qualify, select and grant a soccer seasonal partial or full scholarship to the applicants. The scholarship plan is designed to support families requiring financial assistance to be a part of BRI FC. BRI FC cannot assure that every application will be approved for a scholarship. Please note that our Scholarship Program does not cover uniform expenses, league fees, tournaments and/or travel expenses and it requires that the player and the parents sign the BRI FC Financial Contract and Player Release Policy.

## B. Application & Deadlines

The application process will start April 20<sup>th</sup>. All application must be received by May 10<sup>th</sup>. **Late applications will not be accepted.** All applications will be reviewed as they are received. Scholarship recipients will be notified via email no later than May 30<sup>th</sup> if they will be receiving any assistance.

## C. How to Apply.

To be considered for a scholarship, the player must complete each step described below:

- Complete the form below
- Families with multiple children should apply under one family application
- Submit your most recent Tax Return (just the declarations page).
- If you do not have a tax return, please turn in two consecutive pay stubs for all working members of your family.

## D. Qualification & Eligibility Details

To be eligible for the BRI FC Scholarship, the player must meet the following criteria:

- Player must make the initial payment for Uniform cost.
- Scholarships will be reflected on the SIPLAY Account after the uniform and league fee is paid.
- Scholarships will be revoked for players that don't follow through with the BRI FC Financial Contract and Player Release Policy.
- Recipients should make a reasonable effort to give back to the academy by volunteering at the academy or helping out when possible.
- Please note that our Scholarship Program does not cover uniform expenses, league fees, tournaments and/or travel expenses.

## E. Continuing Eligibility

Scholarship recipients must meet the following ongoing standards to qualify for assistance. Failure to comply with the items below will result in removal from the scholarship program.

- Remain current in Academy Dues.
- Meet volunteer requirements.
- Must maintain 95% attendance to practice and games.
- Violation of Academy rules and policies may result in a scholarship being revoked.
